that the Bears invited Gold E. Locks into their home by leaving the door open. Gold E. Locks merely thought she was invited for breakfast. We will show that Gold E. Locks was a guest and certainly did not demonstrate any bad manners."

"My name is Golden Locks. I am also called Gold E. Locks. I live with my mother Locks, my

father Locks, my baby brother Locks, and my kitty cats Spook Locks and Funny Locks. We live in the Big Woods, across Parker's Creek from the Bears. That is my mother -Locks."

CUT TO END OF GOLD E. LOCKS' TESTIMONY

---CARD # 19 ROLE # 6 GOLD E. LOCKS

"I see Babe E. Bear at school all the time. Babe E. even told me that sometime I should come

over and have some porridge because Mommy Bear made it so good! I really didn't mean to harm anything and I'm really sorry about the chair, but I still don't think I broke it."

CARD # 20 ROLE # 2 JUDGE "Are there any summaries?"

## CARD # 21 ROLE # 3 ATTORNEY FOR BEARS

"Your honor, we have shown that Gold E. Locks, without being invited, walked into the Bears' home, ate their porridge, broke a chair, and slept in Babe E. Bear's bed. I am sure the jury agrees that anyone who displays good manners does **not** do such things."

### CARD # 22 ROLE # 4 ATTORNEY FOR LOCKS

"Your honor, we have shown that Gold E. Locks is basically a good little girl. She meant no harm

in going into the house since the door was open. She certainly did not display any bad manners. In fact, she showed good manners by waiting to thank the Bears for their hospitality."

# CARD # 23 ROLE # 2

# JUDGE

(Talking to the JURY). "You have heard the evidence. Now it is your job to decide whether Gold E. Locks showed bad manners".
