
Jones Grove Deed History



Narrative

The subject tract was once part of an extensive plantation assembled by Francis Jones during the period 1794 to 1810. Totaling over 1,700 acres, the plantation comprised the area between Bush Creek and Pokeberry Creek and came to be called "Jones Grove." Upon Jones' death in 1844, ownership passed to his only child Delia, wife of Dr. James S. Smith (of Hillsboro), then to grandson Dr. Francis ('Frank') Jones Smith. Upon Smith's death in 1877, his sister Mary Ruffin Smith gave 300 acres to three of her nieces (former slaves) but left most of the property to the University of North Carolina to sell off and to use the proceeds to establish a student scholarship fund in her brother Francis' name. The northern portion of what was Jones Grove now comprises the southern portion of Fearrington Village and all of Galloway Ridge.


